The history of active shooters

The Avoid, Deny, Defend plan for survival What to expect when the police arrive

Captain Troy Squire has been with the Lawrence Police Department since September of 1996. He graduated from the Lawrence Police Department's 16th Basic Recruit Academy. In 1999 he was assigned to the Douglas County Drug Enforcement Unit as a narcotics investigator. In 1999, he was also assigned to the Law

rence Police Department's Crisis Response Team. In 2004 he was promoted to Detective, and in 2006 he was promoted to Sergeant. As a Sergeant he was assigned to supervise the drug enforcement unit, the investigations division, one of the crisis response teams, and numerous patrol



shifts. In 2017 he was promoted to Captain and assigned to the patrol division. Captain Squire currently serves as Captain over day shift patrol, and is responsible for the department's active shooter preparedness.

Supporting Mental Health in the Workplace

This program will provide an overview of the Mental Health First Aid program, an international program designed to engage conversation and teach individuals how to respond to someone who is having a mental health crisis. In addition, the program will cover crisis services in the Douglas County community, and the value of offering mental health support in the workplace following a workplace crisis or sentinel event.
